Thank you for the opportunity to bid on the Traverse City Fire Department's uniforms.

The submitted bid includes individual pricing if ordering for one fireman/firewoman per order and also as a group or bulk order. I recommend bulk ordering twice per year and individual ordering only when necessary. The savings by ordering in bulk will be a significant savings to the Fire Department and city of Traverse City.

All items quoted have followed the request for proposal guidelines; with the exception of items that have a small content of polyester, due to elastic waist and arm bands. JenTees has chosen to quote a total of seventeen of the items listed. We are focusing on the items we are most familiar with, all polos, sweatshirts, t-shirts, uniform shorts, work-out shorts, baseball caps, and the raincoat. We will not bid on the fireproof dress clothing. We can provide a sample of all items quoted if necessary.


