- B. An Ordinance amendment to the Traverse City Code Section 1374.04, *Driveways and Access Requirements*, to permit driveways within the C-4 District, subject to conditions. Public hearing.**
- C. An Ordinance amendment to the Traverse City Code Section 1334.01, *Uses Allowed*, to allow for additional uses along arterial and collector streets within the R-2 (Two-Family Dwelling) District. Public hearing.**
- D. An Ordinance amendment to the Traverse City Code Section 1374.06, *Drive-Through Standards*, to require that a pedestrian service area, physically separate from all vehicular circulation be in operation at any time the drive-through is in use. Public hearing.**
- E. An Ordinance amendment to the Traverse City Code Section 1334.03, *Lot, Density and Impervious Surface Provisions*, in the R-2 (Two-Family) District to reduce the minimum lot area requirement for two family dwellings. Public hearing.**
- F. An Ordinance amendment to the Traverse City Code Section 1320.04, *Changes and Amendments*, to modify the ordinance to comply with the Michigan Zoning Enabling Act to state that if eleven or more adjacent properties are proposed for rezoning than notification, other than the local paper, is not needed, a housekeeping matter. Public hearing.**
- G. An Ordinance amendment to the Traverse City Code of Ordinances Sections 482, of the Traffic Code, 1332.08, 1334.08, 1336.08, 1338.08, 1340.08, 1342.08, 1344.08, 1374.03 and 1374.04 of the Zoning Code to change the requirements for parking on residential lots. Introduction and schedule for a public hearing on May 9, 2007.**
